### **BACKGROUND & UPDATE**

16 months after the marathon 13-hour hearing held in March 2018, this past Tuesday afternoon, July 2, Phil Mendelson, Chair of the City the City Council, released for the first time publicly his markup of the leading Chapter of the DC Comprehensive Plan, the Framework Element (50+ pages long).

The Framework Element is a leading chapter of the plan, setting the overarching goals and principles of the future vision and development potential of our city. This chapter also defines the development maps of the city called the Future Land Use Map and Generalized Policy Map.

# HERE'S OUR REVIEW OF PROPOSED AMENDMENTS TO THE FRAMEWORK ELEMENT

\*\* What's Not in the Framework, Yet \*\*

- **1) RACIAL EQUITY IS MISSING** Without the principle of racial equity centrally highlighted in the Comprehensive Plan, we are missing a key planning principle critically important to ending the displacement & disparities that have and continue to exist in our city >> http://www.dcgrassrootsplanning.org/heal-the-past/
- **2) DISPLACEMENT & OTHER IMPACTS LARGELY MISSING** -- The concern about displacement of longtime DC neighborhoods and people of color continues to be downplayed by the Office of Planning and by the Chairman. For example, there's absolutely no mention of the recent data and reports showing that DC is leading the nation in gentrification and displacement of Black families and working people. Where displacement is mentioned in the Framework edits, its limited in scope to

"on-site" displacement by projects like that at Barry Farms. The edits care not about rising gentrification pressures on impacted communities surrounding new luxury projects >> http://www.dcgrassrootsplanning.org/clean-this-place-dont-displace/

**3) LAND VALUE RECAPTURE NOT EMPHASIZED** -- The basic planning concept of land value recapture got a brief nod in the Framework Element but is limited to certain "Land Use Change Areas" of the city. We want to see that when any project or program in any part of the city get any public subsidy, including zoning entitlements, that the value of the land and air rights granted be used to meet the city's social equity needs, like truly affordable family sized housing. # MENDELSON ADOPTS OP'S SQUISHY DEFINITIONS THAT SUPPORT DC'S KEY MAPS

Chairman Mendelson postured to the Coalition that he would clarify and sharpen the definitions that support the Future Land Use Map and Generalized Policy Map. The maps can be "interpreted broadly" and are only "general guides." Phil goes further and says these maps are "soft-edged" allowing the creeping of higher density zoning into lower density residential areas. The Coalition wants stronger, clearer terms that describe our city's planning maps. We want to eliminate the flexibility and discretion that the Zoning Commission has used liberally in recent years to push up building densities in areas of the city not expecting sudden upzoning and the impacts therein >> https://tinyurl.com/dcgpc-map-amendments
